Supplement to the General Order of 1 December 2006

I, Stephen Phillip Bracks, Premier of Victoria, state that the following administrative arrangements for responsibility for the following Acts, provisions of Acts and functions will operate in place of the arrangements specified in the Administration of Acts General Order of 1 December 2006 as amended, in relation to the Acts specified in the Order.

MINISTER FOR CHILDREN

(These Parts are jointly and severally administered with the Minister for Community Services)
- Part 6
(This Part is administered by the Minister for Community Services)

MINISTER FOR COMMUNITY SERVICES

Adoption Act 1984 –

- The Act is jointly and severally administered with the Attorney-General

Children and Young Persons Act 1989 –

- The Act is jointly and severally administered with the Attorney-General

Children, Youth and Families Act 2005

- The Act is jointly and severally administered with the Attorney-General

Child Wellbeing and Safety Act 2005

- Parts 4 and 5
(These Parts are jointly and severally administered with the Minister for Children)

Crimes (Mental Impairment and Unfitness to be Tried) Act 1997 –
