

## **ADMINISTRATION OF ACTS**

### **Supplement to the General Order of 23 May 2016**

I, the Hon Daniel Andrews, Premier of Victoria, state that the following administrative arrangements for responsibility for the following Acts of Parliament, provisions of Acts and functions will operate in place of the arrangements specified in the Administration of Acts General Order of 23 May 2016 (as amended by the supplements of 15 September 2016 and 1 August 2017), in relation to the Acts, provisions of Acts and functions specified in this supplement to the General Order.

## **Attorney-General**

### Constitution Act 1975 –

- Part III
- Division 1 of Part IIIAA (this Division is jointly administered with the Premier)
- Divisions 3 to 6 of Part IIIAA
- Section 88 in so far as it relates to the appointment of Crown Counsel and Crown Counsel (Advisings)

(The Act is otherwise administered by the Minister for Training and Skills, the Premier, the Special Minister of State and the Treasurer)

### Family Violence Protection Act 2008 – Except

- Part 5A and Part 11 (these Parts are administered by the Special Minister of State)
- Sections 210A and 210B (these sections are administered by the Special Minister of State)
- Section 211 (this section is jointly and severally administered with the Special Minister of State and the Minister for the Prevention of Family Violence)
- Division 1A of Part 13 (this Division is administered by the Special Minister of State)

(The Act is otherwise jointly and severally administered with the Minister for the Prevention of Family Violence)

## **Minister for the Prevention of Family Violence**

### Family Violence Protection Act 2008 – Except

- Part 5A and Part 11 (these Parts are administered by the Special Minister of State)
- Sections 210A and 210B (these sections are administered by the Special Minister of State)
- Section 211 (this section is jointly and severally administered with the Special Minister of State and the Attorney-General)
- Division 1A of Part 13 (this Division is administered by the Special Minister of State)  
(The Act is otherwise jointly and severally administered with the Attorney-General)

## **Premier**

### Constitution Act 1975 – Except

- Section 72 (this section is administered by the Special Minister of State)
- Part III (this Part is administered by the Attorney-General)
- Division 1 of Part IIIAA (this Division is jointly administered with the Attorney-General)
- Divisions 3 to 6 of Part IIIAA (these Divisions are administered by the Attorney-General)
- Section 88 (in so far as it relates to the appointment of Crown Counsel and Crown Counsel (Advisings), this section is administered by the Attorney-General)
- Section 88 (in so far as it relates to the appointment of the Commissioner for Better Regulation and the Red Tape Commissioner, this section is administered by the Treasurer)
- Section 88 (in so far as it relates to the appointment of the Victorian Skills Commissioner, this section is administered by the Minister for Training and Skills)


**Special Minister of State**

  - Sections 210A and 210B
  - Section 211 (this section is jointly and severally administered with the Minister for the Prevention of Family Violence and the Attorney-General)
  - Division 1A of Part 13
- (The Act is otherwise jointly and severally administered by the Attorney-General and the Minister for Prevention of Family Violence)
