

The Bosnia-Herzegovina-Born Community in Victoria – 2016 Census (ranked 41)



At the 2016 Census, there were 8,487 Bosnia-Herzegovina-born persons in Victoria (35.4 % of Australia's total), ranked 41st among the overseas-born communities in Victoria. The Bosnia-Herzegovina-born decreased by 7.4% (676) from 9,163 persons in 2011. They are distributed throughout Metropolitan Melbourne, with significant concentrations in the LGAs of Greater Dandenong (18.1%), Brimbank (14.1%), Casey (13.3%) and Melton (6.0%).

The Bosnia-Herzegovina-born reflected a mature age profile: 8.6% were aged 25 years and below; 33.3% were aged 26-44 years; 40.7% were aged 45-64 years; and 17.5% were aged 65 years and over. The median age was 49 years, compared to 37 years for total Victoria. The gender ratio was 93 males to 100 females, compared to 96 males to 100 females for Victoria.

There were 8,482 persons identified with Bosnia-Herzegovina ancestry. Most were born in Bosnia-Herzegovina (54.9%) and Australia (32.2%). Almost half (45.4%) of the Bosnia-Herzegovina-born in Victoria had arrived in Australia prior to 1996; 35.9% arrived in 1996-2000; 11.1% arrived in 2001-2005; 3.1% arrived in 2006-2010; and 2.8% arrived in 2011-2016.

The Bosnia-Herzegovina-born speak Bosnian (44.8%), Serbian (27.2%) and Croatian (15.2%): 22.6% of those who speak a language other than English speak English not well/not at all. The Bosnia-Herzegovina-born follow a variety of religions: Islam (26.4%), Eastern Orthodox (19.0%), Catholic (18.9%) and Christians not further defined (8.1%); 19.9% have no religion. Most (93.6%) have Australian citizenship, compared to 58.3% for the total overseas-born population in Victoria.



Economic characteristics

The education levels of the Bosnia-Herzegovina-born are different from those for total Victoria: 18.4% have a bachelor degree or higher and 59.4% have a certificate or school education only (24.3% and 53.1% for Victoria).

The labour force participation rate of the Bosnia-Herzegovina-born at 55.2% is lower than for total Victoria at 60.5%. Their unemployment rate at 5.6% is also lower than total Victoria at 6.6%.

The occupational patterns of the Bosnia-Herzegovina-born differ from those for total Victoria. More of them are working as technicians and trades workers (18.6%), machinery operators and drivers (10.6%) and labourers (14.4%) compared to Victoria (13.1%, 5.8% and 9.0%). Less of the Bosnia-Herzegovina-born are working as managers (9.4%) and professionals (17.2%) compared to Victoria (13.5% and 23.3%).

The industry of employment patterns for the Bosnia-Herzegovina-born are fairly similar to those for total Victoria. The exceptions are that more of them are employed in manufacturing (12.0%) and construction (17.1%), compared to 7.8% and 8.3% for Victoria. Less of them are employed in accommodation and food services (3.1%) and education and training (5.4%), compared to Victoria (6.6% and 8.6%).

The weekly personal income distribution pattern for the Bosnia-Herzegovina-born is also fairly similar to total Victoria, except that 29.5% receive \$1.4399 compared to 20.1% for Victoria; and 16.8% receive \$1,250 or more (21.1% for Victoria).
