

# The Bulgaria-Born Community in Victoria – 2016 Census (ranked 96)



At the 2016 Census, there were 989 Bulgaria-born persons in Victoria (30.1% of Australia's total), ranked 96<sup>th</sup> among the overseas-born communities in Victoria. The Bulgaria-born increased by 10.4% (93) from 896 persons in 2011. They are well distributed throughout Metropolitan Melbourne, with minor concentrations in the LGAs of Casey (6.7%), Greater Dandenong (6.4%), Stonnington (5.0%), Brimbank (4.9%) and the regional LGA of Greater Geelong (5.1%).

The Bulgaria-born reflected a mature age profile: 9.2% were aged 25 years and below; 36.4% were aged 26-44 years; 34.9% were aged 45-64 years; and 18.9% were aged 65 years and over. The median age was 46 years, compared to 37 years for total Victoria. The gender ratio was 82 males to 100 females, compared to 96 males to 100 females for total Victoria.

There were 1,898 persons identified with Bulgarian ancestry. Most of them were born in Australia (42.7%) and Bulgaria (40.4%). Almost half (45.2%) of the Bulgaria-born in Victoria had arrived in Australia prior to 1996; 11.3% arrived in 1996-2000; 11.7% arrived in 2001-2005; 12.5% arrived in 2006-2010; and 18.1% arrived in 2011-2016.

Over half (55.1%) of the Bulgaria-born speak Bulgarian and 19.5% speak Turkish. Of those who speak another language, 12.8% speak English not well/not at all. The Bulgaria-born follow a variety of religions: 35.9% are Eastern Orthodox; 16.6% follow Islam; and 14.4% are Christians not further defined; 20.8% have no religion. Three-quarters (75.1%) have Australian citizenship, compared to 58.3% for the total overseas-born population in Victoria.





# **Economic characteristics**

The education levels of the Bulgaria-born are fairly different from those for total Victoria: 22.2% have a bachelor degree and 16.1% have a postgraduate degree, compared to 16.5% and 5.4% for total Victoria; 44.6% of the Bulgaria-born have a certificate or school education only compared to 53.1% for Victoria.

The labour force participation rate of the Bulgaria-born at 63.5% is slightly higher than total Victoria at 60.5%. Their unemployment rate at 8.2% is also higher than Victoria at 6.6%.

The occupational patterns of the Bulgaria-born are slightly different from those for total Victoria. One-third (32.5%) work as professionals and 8.5% are machinery operators, compared with 23.3% and 5.8% for Victoria. Less of the Bulgaria-born are technicians and trade workers (11.4%) and clerical and administrative workers (8.7%) compared to 13.1% and 13.3% for Victoria.

The industry of employment patterns of the Bulgaria-born are also different from those for total Victoria. More of them are employed in professional, scientific, technical and administration (17.4%), compared to 11.4% for Victoria; and less are employed in wholesale and retail trade (9.1%), compared to Victoria (13.4%).

The weekly personal income distribution pattern of the Bulgaria-born is fairly similar to total Victoria. The exception is that a slightly higher proportion (42.0%) of the Bulgaria-born receive income of \$800 or more compared to Victoria (37.8%).
