# The El Salvador-Born Community in Victoria — 2016 Census (ranked 69)



#### **Demographic characteristics**

At the 2016 Census, there were 3,166 El Salvador-born persons in Victoria (33.1% of Australia's total), ranked 69<sup>th</sup> among the overseas-born communities in Victoria. The El Salvador-born increased by 0.8% (26) from 3,140 persons in 2011. They are distributed throughout Metropolitan Melbourne, with significant concentrations in the LGAs of Casey (18.8%), Brimbank (15.9%), Melton (11.6%), Wyndham (8.7%) and Hume (7.1%).

The El Salvador-born reflected a mature age profile: 3.6% were aged 25 years and below; 43.6% were aged 26-44 years; 39.5% were aged 45-64 years; and 13.4% were aged 65 years and over. The median age was 46 years, compared to 37 years for total Victoria. The gender ratio was 94 males to 100 females, compared to 96 males to 100 females for Victoria.

There were 3,112 persons identified with Salvadoran ancestry. Most were born in El Salvador (52.8%) and Australia (43.3%). The majority (87.5%) of the El Salvador-born in Victoria had arrived in Australia prior to 1996; 3.5% arrived in 1996 -2000; 1.8% arrived in 2001-2005; 2.7% arrived in 2006-2010; and 2.8% arrived in 2011-2016.

Most (89.2%) of the El Salvador-born speak Spanish. Of those who speak a language other than English, 14.9% speak English not well/not at all. The El Salvador-born follow a variety of religions: Catholic (54.1%), Christianity not further defined (10.0%), Pentecostal (6.2%) and Baptist (5.3%). Most (92.9%) of El-Salvador-born have Australian citizenship, compared to 58.3% for the total overseas-born population in Victoria.





#### **Economic characteristics**

The education levels of the El Salvador-born are fairly similar to those for total Victoria. More of them have an advanced diploma or diploma (13.1%) and certificate (17.4%), compared to total Victoria (9.2% and 14.4%). Less of them have a postgraduate degree (3.5%) and school education only (35.0%), compared to 5.4% and 38.7% for Victoria.

The labour force participation rate of the El Salvador-born at 67.3% is higher than total Victoria at 60.5%. Their unemployment rate at 7.5% is also slightly higher than Victoria at 6.6%.

The occupational patterns of the El Salvador-born are different from those for total Victoria. Less of them work as managers (7.7%), professionals (17.7%) and technicians and trades workers (11.7%), compared to Victoria (13.5%, 23.3% and 13.1%). More of the El Salvador-born work as community and personal service workers (14.7%), machinery operators and drivers (10.5%) and labourers (18.4%), than Victoria (10.6%, 5.8% and 9.0%).

The industry of employment patterns for the El Salvador-born are also different from those for total Victoria. Less of them are employed in construction (5.8%), wholesale and retail trade (9.5%) and accommodation and food services (3.5%), compared to Victoria (8.3%, 13.4% and 6.6%). More of them are employed in transport, postal and warehousing (7.4%), professional, scientific, technical and administration (16.0%) and healthcare and social assistance (19.0%) than Victoria (4.8%, 11.4% and 12.5%).

The weekly personal income distribution pattern for the El Salvador-born is fairly similar to total Victoria. The exception is that more of them receive \$1-\$399 (23.0%), \$400-\$799 (27.0%) and \$800-\$1,249 (22.3%), compared to Victoria (20.1%, 23.1% and 16.7%). Less of them (4.1%) receive \$2,000 or more, compared to Victoria (7.5%).
