Pits must be designed, constructed and maintained to: 							
 Allow the safe display or demonstration of dangerous wildlife from within the enclosure; Prevent the escape of any dangerous or venomous wildlife from within the enclosure; and Ensure the walls of the enclosure are constructed from solid and sturdy materials with no gaps or holes that may allow a person outside the enclosure to protrude any part of their body through the walls.
