Wildlife Basic Licence	Authorises the holder to possess, keep, breed, buy, sell and dispose of any wildlife (whether alive or dead) listed in Schedules 2 & 7 of the Wildlife Regulations 2013 for non-commercial purposes.
Wildlife Advanced Licence	Authorises the holder to possess, keep, breed, buy, sell and dispose of any wildlife (whether alive or dead) listed in Schedules 2, 3 & 7 of the Wildlife Regulations 2013 for non-commercial purposes.
Wildlife Specimen Licence	Authorises the holder to possess, keep, buy, sell and dispose of prepared or mounted specimens of any dead wildlife for non-commercial purposes.

The minimum age for applicants is 10 years of age. A licence will only be issued to you at your Primary Residential Address. This form is not valid after 30 June 2021.

If your application is approved, you will receive a Payment Notice showing the amount payable and options for payment. The amount payable is calculated in accordance with Regulation 19(3) of the Wildlife Regulations 2013, taking into account the annual rate (below), the number of months (or part months) remaining of the term, less 50% concession (if eligible).

2. If your application is approved, a Payment Notice will be sent to you for payment within 30 days.

3. When your payment is processed, your Wildlife Licence and Protected Wildlife Record Book will be sent to you.

<u>Please note</u>: If applying by mail, please allow at least 3 weeks to receive your licence. If applying by email, please allow at least 2 weeks to receive your licence. Incomplete or incorrect applications may delay approval of your application.
