## **Further information on Wildlife Licence Amendments**

In Victoria, Wildlife Licences and authorisations are issued under the Wildlife Act 1975 and the Wildlife Regulations 2013.

The holder of a Wildlife Licence, permit or authority must notify the Secretary within 10 business days of any change of name or address provided to the Secretary in relation to the licence, permit or authority. To register changes associated with employees of a Commercial Wildlife Licence Holder, please use the *Register of Employees Amendment Form* which is available from <a href="https://www.delwp.vic.gov.au">www.delwp.vic.gov.au</a> or by calling 136 186.

Any request to change the operating premises specified in your wildlife licence may be subject to an on-site inspection by an Authorised Officer to assess suitability of the premises for housing wildlife.

#### **National Police Certificate**

Provision is made under Section 23(1)(a) of the *Wildlife Act 1975* for the Secretary to refuse to grant an application if (for example) the Applicant is not a fit and proper person. For this reason, request to change the nominated 'Responsible Person' (Part 5) must be supported by a copy of 'National Police Certificate', issued within the last two years.

This can be obtained from Victoria Police, by completing VP Form 820A 'Consent to check and release National Police Record', which is available from your local Police Station, or online from <a href="https://www.police.vic.gov.au">www.police.vic.gov.au</a>. Please note, only a copy of a 'National Name Check' is required.

DELWP will only take into account those matters relevant to the type of licence.
