

Information Sharing and MARAM Online Learning System Account Creation and Training Guide – Catholic Schools

This guide is for Education professionals in Catholic schools who would like to enrol in courses related to the information sharing reforms, including the Child Information Sharing Scheme (CISS) and Family Violence Information Sharing Scheme (FVISS).

We recommend using a laptop or a desktop computer. Our courses are interactive and may not display correctly on smartphones and tablets.



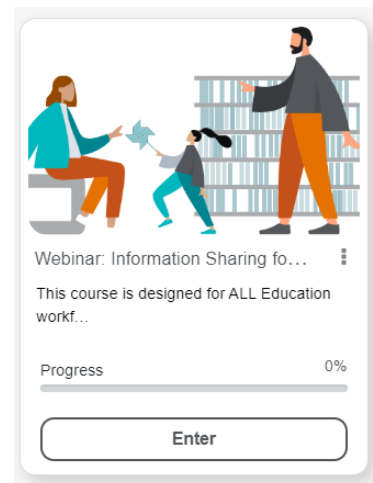
Once you are logged in, go to the Homepage and enter **Education Workforces**.

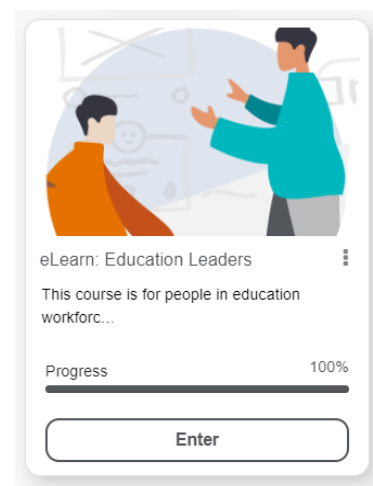
This webinar will take around 3 hours.

You can work through the modules at your own pace, at any time.

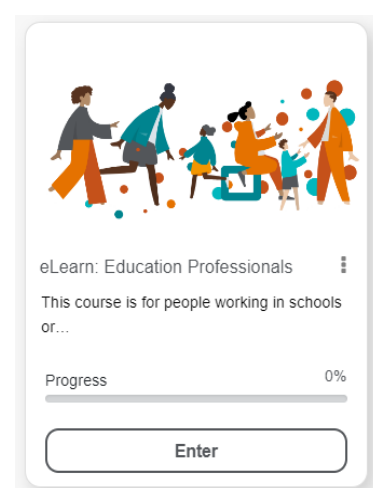
The eLearn consists of five modules, which each take around 25 minutes to complete. The entire course will take around 2 hours.
