# Introduction

This guide is for anyone who needs to know about a full club licence and its conditions. This may include:

- new club committee members, nominees or managers
- existing committee members
- staff at a club with a full club licence.

Once you have completed this guide, you should be able to:

- identify when and where you are allowed to supply alcohol to members and their guests
- identify any special conditions that apply to your licence type
- identify possible breaches of a full club licence.

# General information

<b>Trading Hours</b>	<p>A full club licence allows you to:</p> <p>Sell alcohol to drink at your club to members, members' guests, authorised gaming visitors and the general public at club events or functions:</p> <ul style="list-style-type: none"> <li>• Any time, Monday to Saturday</li> <li>• Sunday, 10 am to 11 pm</li> <li>• ANZAC Day and Good Friday, 12 noon and 11 pm</li> <li>• Between 1 am and 3 am on 1 January</li> <li>• During any other times <b>only if specified in the licence.</b></li> </ul> <p>A full club licence also allows you to sell alcohol from the club to members attending the club to drink away from your venue:</p> <ul style="list-style-type: none"> <li>• Any time, Monday to Saturday</li> <li>• Sunday, 10 am to 11 pm</li> <li>• ANZAC Day and Good Friday, 12 noon and 11 pm</li> <li>• During any other times <b>only if specified in the licence.</b></li> </ul> <p>If your licence specifies trading hours for specific areas of the club you will need to comply with those specific trading hours.</p> <p>You must have planning permission from your local council to trade during the trading hours displayed on your liquor licence.</p> <p>You have a 30-minute period after closing time for customers to finish purchased drinks. During this time, you cannot sell customers any more alcohol.</p>
<b>Liquor licence and posters</b>	<p>You are required to display:</p> <ul style="list-style-type: none"> <li>• a copy of the current liquor licence where customers can see it</li> <li>• the following posters (signage): <ul style="list-style-type: none"> <li>– 'Intoxicated, Drunk Disorderly?'</li> <li>– 'Under 18? No supply'.</li> </ul> </li> </ul> <p>Posters must be printed in colour on A4 (210 x 297 mm) paper and displayed so members, guests and visitors can see the information.</p>
<b>Red line plan</b>	<p>Your red line plan (the plan) shows where alcohol can be sold, served and consumed. The plan is submitted with a licence application. If the licence is transferred to you from an existing licence owner, Liquor Control Victoria (LCV) will have an approved plan. If Victoria Police or a liquor inspector visits you, they will likely request a copy of your plan to check that you are operating within the red line area.</p>
<b>Amenity</b>	<p>Amenity is the impact your club, members or visitors may have on the surrounding area. Your club should consider the following amenity impacts:</p> <ul style="list-style-type: none"> <li>• <b>Parking facilities</b> Do you have a car park? Do members or visitors park in nearby residential streets?</li> </ul>

	<ul style="list-style-type: none"> <li><b>Traffic movement and density</b> Is there a high volume of traffic in the surrounding area from members or visitors coming to your club?</li> <li><b>Noise levels</b> What measures do you have in place to minimise noise from your club (if you have amplified music) or from members or visitors leaving your club?</li> <li><b>Possibility of nuisance or vandalism</b> Are your members or visitors likely to cause a nuisance to nearby residents? Could they cause noise, nuisance or damage to property?</li> <li><b>Harmony and coherence of the environment</b> What general effect does your club have on the local community and neighbouring businesses/residents?</li> </ul>
<b>Liquor deliveries</b>	<p>Only club members can order alcohol via an off-premises request (that is orders taken by phone, fax, internet or mail order). You must notify LCV before taking off-premises orders. For more information see <a href="http://vic.gov.au/off-premises-requests-for-alcohol-delivery">vic.gov.au/off-premises-requests-for-alcohol-delivery</a>.</p> <p>You must comply with the following conditions set out in section 18C of the Act:</p> <ul style="list-style-type: none"> <li><b>Display your licence number</b> clearly on your website or ordering platform and in any promotional or advertising materials.</li> <li><b>Display a warning notice</b> where customers place their order (for example, a website or ordering platform) about offence to supply alcohol to a person under 18.</li> <li><b>Instruct delivery drivers</b> that: <ul style="list-style-type: none"> <li>alcohol can only be delivered until 11 pm</li> <li>same-day orders must be delivered to the person who ordered the alcohol and cannot be left unattended.</li> </ul> </li> <li><b>For first time orders</b> (that are not gifts): <ul style="list-style-type: none"> <li>customers must confirm they are aged 18 or over</li> <li>delivery drivers must be instructed that: <ul style="list-style-type: none"> <li>alcohol must be delivered to the customer who made the order and</li> <li>they must see an ID document confirming the person is aged 18 or over.</li> </ul> </li> </ul> </li> <li><b>For subsequent orders</b> by the same customer, you are required to: <ul style="list-style-type: none"> <li>obtain instructions where to leave the order if the customer is not at home</li> <li>provide these instructions to the driver and advise that the order must be delivered per the customer's instructions.</li> </ul> </li> <li><b>For gift orders</b>: <ul style="list-style-type: none"> <li>customer must confirm that they and the person receiving the gift are aged 18 or over</li> <li>you must obtain the name and address of the gift recipient</li> <li>delivery driver must be instructed to only deliver the alcohol to: <ul style="list-style-type: none"> <li>the address provided</li> <li>the gift recipient or a person who is aged 18 years or over</li> <li>the recipient, who must provide an <a href="#">acceptable form of identification</a>.</li> </ul> </li> </ul> </li> </ul> <p>A report of failed alcohol deliveries must be provided to LCV by 30 July each year. For further information see <a href="http://vic.gov.au/off-premises-requests-for-alcohol-delivery">vic.gov.au/off-premises-requests-for-alcohol-delivery</a>.</p>

<b>Registers</b>	<p>Clubs must keep the following registers:</p> <ul style="list-style-type: none"> <li>• <b>Members' register</b> <ul style="list-style-type: none"> <li>– showing the name and address of each member and their membership subscription. Members are not required to sign in each time they use the club; the register is to show who the members are.</li> </ul> </li> <li>• <b>Guests' register</b> <ul style="list-style-type: none"> <li>– showing guest/visitor's names and addresses (residential or email), the member they are a guest of (if applicable), and the date they visited the club.</li> </ul> </li> <li>• <b>Gaming visitors' register</b> for clubs with a venue operator's licence (that is gaming machines) <ul style="list-style-type: none"> <li>– must contain the gaming visitors' names and addresses and the date they visited the premises.</li> </ul> </li> </ul> <p>Gaming visitors should produce identification before being allowed into the club and always carry it with them.</p> <p>The club secretary is responsible for ensuring registers are available for inspection by Victoria Police or a liquor inspector.</p>
<b>Underage members and visitors (minors)</b>	<p><b>Minors are not allowed to be served or drink alcohol at your club under any circumstances.</b></p> <p>Many sporting clubs have junior teams training and playing games at the club. Clubs must apply to LCV for permission to allow anyone under 18 years old to participate in club activities. The permanent underage authority form is available at: <a href="http://vic.gov.au/make-changes-to-liquor-licence">vic.gov.au/make-changes-to-liquor-licence</a>.</p> <p>Where permission is granted, your club licence will state the terms and conditions. This usually includes a set time by which minors must leave your club premises and any other conditions that may apply.</p> <p>Persons under 18 years of age may be in your club if they are:</p> <ul style="list-style-type: none"> <li>• in the company of a 'responsible adult', or</li> <li>• having a meal, or</li> <li>• employed in duties other than the supply of alcohol (for example, preparing food, taking orders (other than for alcohol)), or</li> <li>• in an LCV approved hospitality training program, or</li> <li>• otherwise approved by LCV to be there.</li> </ul> <p>A responsible adult is a person who is over the age of 18 years and who is:</p> <ul style="list-style-type: none"> <li>• the younger person's parent, step-parent, guardian or grandparent</li> <li>• the younger person's spouse (over the age of 18 years)</li> <li>• a person acting instead of a parent and supervising the young person (for example, an aunt or uncle).</li> </ul> <p>More information on responsible adult is available at: <a href="http://vic.gov.au/under-18s-at-licensed-venues">vic.gov.au/under-18s-at-licensed-venues</a>.</p>
<b>Sub-letting</b>	<p>You must seek LCV approval to sublet all or part of the licensed premises to another business. To apply, complete the <i>Sublet premises or right to supply alcohol</i> form available at <a href="http://vic.gov.au/make-changes-to-liquor-licence">vic.gov.au/make-changes-to-liquor-licence</a>.</p>

<b>Allowing other persons to carry on a business of supplying alcohol</b>	You must seek approval of LCV if anyone else, except you or your employee, is to supply alcohol at your club. To apply, complete the <i>Sublet premises or right to supply alcohol</i> form available at <a href="http://vic.gov.au/make-changes-to-liquor-licence">vic.gov.au/make-changes-to-liquor-licence</a> .
<b>Other</b>	<p>Relevant information about your licence:</p> <ul style="list-style-type: none"><li>• Annual licence renewal is due on 31 December. A good compliance history can reduce your fees see <a href="http://vic.gov.au/demerit-points-and-star-ratings-for-licensees">vic.gov.au/demerit-points-and-star-ratings-for-licensees</a>.</li><li>• Join the Liquor Portal at <a href="http://liquorportal.vic.gov.au/liquorportal">liquorportal.vic.gov.au/liquorportal</a> to access your licence, renewal notice and update your details.</li><li>• Apply for a temporary licence at <a href="http://vic.gov.au/apply-temporary-limited-liquor-licence">vic.gov.au/apply-temporary-limited-liquor-licence</a> if you wish to extend your trading hours or red line area for a one-off event.</li><li>• Change what your licences allows you to do by completing the variation to an existing licence form at <a href="http://vic.gov.au/make-changes-to-liquor-licence">vic.gov.au/make-changes-to-liquor-licence</a>.</li><li>• Surrender your licence when you no longer need it at <a href="http://vic.gov.au/cancel-liquor-licence">vic.gov.au/cancel-liquor-licence</a>.</li><li>• Stay compliant with liquor laws and your obligations as a licence holder at <a href="http://vic.gov.au/stay-compliant-for-liquor-licensees">vic.gov.au/stay-compliant-for-liquor-licensees</a></li></ul>

**GENERAL INFORMATION**  
A liquor licence does not override local laws, planning schemes and conditions on planning permits. It is the responsibility of the licensee to ensure they comply with these and all conditions of a planning permit above what is specified on the liquor licence. Where the trading hours on your planning permit are less than the trading hours on this liquor licence, you must comply with the hours on the planning permit.

**TYPE OF LICENCE**  
This licence is a full club licence and authorises the licensee to supply liquor on the licensed premises during the trading hours specified below:-

- (a) to a member of the club for consumption on or off the licensed premises; and
- (b) to an authorised gaming visitor or guest of a member for consumption on the licensed premises; and
- (c) to members of the public at functions and club events for consumption on the licensed premises.

**AMENITY**  
The licensee shall not cause or permit undue detriment to the amenity of the area to arise out of or in connection with the use of the premises to which the licence relates during or immediately after the trading hours authorised under this licence.

**MAXIMUM CAPACITY**  
340 patrons

For consumption on the licensed premises -  
Monday to Saturday, excluding Good Friday & Anzac Day  
Good Friday  
Anzac Day (falling on Monday - Saturday)  
Anzac Day (falling on a Sunday)  
Sunday (being Christmas Eve or Day; New Year's Eve or Day)  
Sunday (not being an Anzac Day)

At any time.  
Between noon and 11.30p.m.  
Between noon and midnight.  
Between noon and 11.30p.m.  
Between midnight and 1a.m.; also 10a.m. and midnight.  
Between midnight and 1a.m.; also 10a.m. and 11.30p.m.

**APPROVALS/CONSENTS**  
Section 120 The licensee has the approval of the Liquor Regulator to allow the presence of underaged persons on the licensed premises in connection with sporting activities only. This approval does not include social activities (but does include attendance at a presentation function).

Section 105 Consent to let or sublet. The terms and conditions of the consent given to the licensee under section 105 are incorporated as terms and conditions of the licence as if set out here in full.  
This approval for Perfect Putt Golf Club Inc to let/sub-let part of the licensed premises expires on 1 January 2036.



## Answers

Q.1 Yes, members may take alcohol off the premises during off-premises trading hours.

Q.2 No, you are not allowed to sell alcohol for off-premises consumption to non-members at any time.

Q.4 Yes, a full club licence allows for supply of alcohol to members of the public at functions on your licensed premises.

Q.5 No, these areas are outside the red plan.

Q.6 True.

Q.7 Yes, a licensee must not let or sublet any part of the licensed premises or assign the right to supply alcohol without the consent of LCV.

Q.8 Possible amenity concerns:

- Noise—music and the group being louder due to alcohol
- Alcohol related violence
- Traffic—there could be additional traffic when members and guests are leaving the club
- Possibility of nuisance or vandalism to the local area.

Q.9 No, Joey is in the company of a responsible adult.

Q.10 Possible strategies to ensure anyone under 18 years old is not served alcohol:

- Have 'Under 18? No supply' poster displayed in a place that is visible to your members and their guests.
- Ensure staff are RSA trained and they always ask for ID when someone looks underage.
- Provide information regarding underage laws to members.
- Consider issuing coloured wristbands to persons who have shown acceptable ID.
